ORDINANCE NO. 1978-M-31

AN ORDINANCE AMENDING ARTICLE IV, PUBLIC TOILET FACILITIES, CHAPTER 19, OF THE MUNICIPAL CODE OF THE CITY OF ST. CHARLES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Article IV, Public Toilet Facilities, Chapter 19, of the Municipal Code of St. Charles, is deleted and the following substituted therefor:

ARTICLE IV. PUBLIC TOILET FACILITIES

19.401 Sanitation) Any business establishment, firm or association providing toilet facilities for the general public shall maintain said facilities in a clean and sanitary condition, in good repair, well lighted and ventilated by means of a mechanical fan or openable screened window, and the door to such facility shall be self-closing. Adequate handwashing facilities, including running water, soap and sanitary towels or drying devices shall be provided.

19.402 License) It shall be unlawful for any business establishment, firm or association to provide toilet facilities for the general public without having first obtained a license therefor. Application for such license shall be made in writing to the City Clerk. The annual fee for such license shall be \$15.00.

19.403 Installation) Installation of such facilities shall comply with provisions relating to plumbing in this Code.

19.404 Penalty) Any person, firm or corporation violating any of the provisions of this article shall be fined not less than One Dollar nor more than Five Hundred Dollars for each offense, and a separate offense shall be deemed committed on each day during or on which a violation occurs or is permitted to continue.


2. That Article IV, Public Toilet Facilities, Chapter 19, of the Municipal Code of St. Charles, as hereinbefore and hereafter amended shall remain in full force and effect.

3. That this Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
