AN ORDINANCE AMENDING TITLE 10, "VEHICLES AND TRAFFIC", CHAPTER 10.41, "HANDICAPPED PARKING", OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 10, "Vehicles and Traffic", Chapter 10.41, "Handicapped Parking", of the St. Charles Municipal Code, be and is hereby amended as follows:

a. By deleting Section 10.41.010 and substituting the following:

"10.41.010 Handicapped Parking Devices.

The City shall provide a handicapped motorist device which shall be issued to a handicapped person. This device shall be the property of such handicapped individual and may be used only by that person to designate and identify a vehicle not owned or displaying a registration plate as provided for in Section 3-609 and 3-616 of Chapter 95 1/2 of the Illinois Revised Statutes (1981 ed) to designate when the vehicle is being used to transport said handicapped person. Such device shall be displayed in the lower left rear window of the vehicle and shall be made

of cardboard, be at least four inches by six inches and shall display the design shown in Exhibit A attached hereto and made a part hereof. Temporary permits shall be designated by the year of issue and the number 1, 2, 3 or 4 in the lower right hand corner of the device, which number shall designate the quarter of the year in which it is valid as follows:

- 1 January through March;
- 2 April through June;
- 3 July through September;
- 4 October through December."

b. That Section 10.41.020, "Applications", be and is hereby amended by adding the following:

"For temporary permits the application shall be in the form appended hereto as Exhibit C. No person may apply for a temporary permit for more than one vehicle."

c. That Section 10.41.040, "Handicapped Parking Locations", be and is hereby amended by deleting the same and substituting the following therefore:

"10.41.040 Handicapped Parking Locations.

It is unlawful for the operator or owner of any vehicle to cause or permit


such vehicle to be parked in any parking place (including any private or public off street parking facility) specifically reserved for a handicapped person or disabled veteran by the posting of an official sign bearing the design and inscription as shown in Exhibit B attached hereto and made a part hereof, unless such vehicle bears registration plates issued to a physically handicapped person or a disabled veteran, or a handicapped parking device bearing the design shown in Exhibit A attached hereto."

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.

## HANDICAPPED PARKING IDENTIFICATION

Sec. 11-1301.2. Special decals for handicapped parking. The Secretary of State shall provide for, by administrative rules, the design, size and color of a handicapped motorist decal or device which shall be used by local authorities in the issuance thereof to a handicapped person. This decal or device shall be the property of such handicapped individual and may be used by that person to designate and identify a vehicle not owned or displaying a registration plate as provided in Sections 3-609 and 3-616 of this Act to designate when the vehicle is being used to transport said handicapped person, and thus is entitled to enjoy all the privileges that would be afforded a handicapped licensed vehicle.

The local governing authorities shall be responsible for the provision of such decal or device, its issuance and designated placement within the vehicle. The cost of such decal or device shall be at the discretion of such local governing authority.
