



BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST.  
CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Chapter 5.48 "Carnivals," Section 5.48.040  
"Insurance Requirements" of the St. Charles Municipal Code be  
and is hereby amended by deleting 5.48.040 and substituting the  
following therefore:

"5.48.040 Insurance Requirements.


A. Prior to a license being issued to operate a  
carnival the applicant shall submit to the City  
of St. Charles a certificate of insurance with  
the owner(s), of the carnival as well as those  
persons acting in similar capacity with respect  
to each entertainment, performance or exhibition  
which collectively make up the carnival, as  
named insured and further naming the City of  
St. Charles as an additional insured in an amount  
of not less than \$2,000,000.00 covering public  
liability, and property damage, said policy  
insuring liability that may arise from the  
operation or maintenance of said carnival of  
any part thereof."

2. That after the adoption and approval hereof the  
Ordinance shall (i) be printed or published in book or pamphlet  
form, published by the authority of the Council, or (ii) within  
thirty (30) days after the adoption and approval hereof  
published in a newspaper in and with a general circulation  
within the City of St. Charles.
