

AN ORDINANCE AMENDING TITLE 12, "STREETS, SIDEWALKS AND  
PUBLIC PLACES", CHAPTER 12.20, "TREES AND SHRUBS",  
OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE  
AND DUPAGE COUNTIES, ILLINOIS, as follows:

1. That Title 12, "Streets, Sidewalks and Public Places", Chapter  
12.20, "Trees and Shrubs", of the St. Charles Municipal Code be and is  
hereby amended by deleting Section 12.20.060, "Types Permitted", and  
substituting the following therefore:

**"12.20.060 Types permitted.**

The street tree planting shall consist of the following types:


A. Types with mature height over fifty feet: Norway maple, sugar  
maple, red maple, black maple, improved silver maple, red oak,  
scarlet oak, pin oak, white oak, oriental and London plane,  
sycamore, sycamore maple, American linden, little-leaf linden,  
silver linden, hackberry, white ash, green ash, ginkgo, tulip  
tree, Kentucky coffee tree; Bradford pear;"

2. That after the adoption and approval hereof, this Ordinance  
shall (a) be printed or published in book or pamphlet form, published by  
the authority of the City Council, or (b) within thirty (30) days after  
the adoption and approval hereof, be published in a newspaper published  
in and with a general circulation within the City of St. Charles.
