

ORDINANCE NO. 1992- M - 28

AN ORDINANCE AMENDING THE ST. CHARLES MUNICIPAL CODE,  
 TITLE 8, "HEALTH AND SAFETY", CHAPTER 8.24,  
 "GARBAGE AND REFUSE", BY AMENDING SECTION  
 8.24.040, "CHARGES AND BILLS" OF THE  
 ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST.  
 CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 8, "Health and Safety", Chapter 8.24 "Garage and Refuse", Section 8.24.040 "Charges and Bills", of the St. Charles Municipal Code, be and is hereby amended by deleting the first paragraph "A" and substituting the following therefore:

"A. The charges for garbage and rubbish, compostable material and recyclable material collection service within the corporate limits of the city shall be as follows:


