

**AN ORDINANCE AMENDING TITLE 17, "ZONING",
OF THE ST. CHARLES MUNICIPAL CODE REGARDING
NURSERY SCHOOLS AND DAY CARE CENTERS**

WHEREAS, a Petition dated November 10, 1992 has been filed to amend Title 17, "Zoning" of the St. Charles Municipal Code regarding nursery schools and day care centers; and

WHEREAS, the Plan Commission of the City of St. Charles has held a public hearing on said Petition in accordance with laws; and

WHEREAS, the City Council of the City of St. Charles has received the recommendation of the Plan Commission and has considered the same;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of St. Charles, Kane and DuPage Counties, Illinois, as follows:

1. That Title 17, "Zoning", of the St. Charles Municipal Code be and is hereby amended as follows:

A. Chapter 17.04, "Rules and Definitions" is hereby amended by adding the following:

"17.04.126 Day Care Center.
"Day Care Center" means any child care facility which regularly provides day care for less than twenty-four hours per day for either a) more than eight children in a family home, or b) more than three children in a facility other than a family home, which meets the licensing requirements of the State of Illinois, Department of Children and Family Services."

and the following:

"17.04.363 Nursery School.
"Nursery School" means an institution providing a regular program of instruction, recognized by the Illinois State Board of Education, for children from three years of age through the first grade level of elementary school."

B. Section 17.22.030 (B-1 District Special Uses) is hereby amended by adding "Nursery Schools and Day Care Centers" in alphabetical order, and by renumbering the list of Special Uses accordingly.

C. Section 17.25.040 (B-2-C District Special Uses) is hereby amended by adding "Nursery Schools and Day Care Centers" in alphabetical order, and by renumbering the list of Special

Uses accordingly.

D. Section 17.26.030 (B-2-T District Special Uses) is hereby amended by adding "Nursery Schools and Day Care Centers" in alphabetical order, and by renumbering the list of Special Uses accordingly.

E. Section 17.32.030 (O-R-1 District Special Uses) is hereby amended by deleting paragraph "G" and by adding the following in lieu thereof:

"G. Nursery Schools and Day Care Centers;"

F. Section 17.36.020 (M-1 District Special Uses) is hereby amended by deleting paragraph "B" and by adding the following item in lieu thereof:


"B. Nursery Schools and Day Care Centers".

2. That this Ordinance shall become effective from and after its passage and approval in accordance with law.


