

**AN ORDINANCE AMENDING TITLE 17, "ZONING",
OF THE ST. CHARLES MUNICIPAL CODE
REGARDING DOG OBEDIENCE SCHOOLS**

WHEREAS, a Petition has been filed by the Director of Planning and Development to amend Title 17, "Zoning" of the St. Charles Municipal Code with respect to the provisions of Chapter 17.36, "M-1 Limited Manufacturing District", Section 17.36.020 "Special Uses" by adding "Dog Obedience School" as a Special Use in the M-1 Limited Manufacturing District; and

WHEREAS, the Plan Commission of the City of St. Charles has held a public hearing on said Petition in accordance with law; and

WHEREAS, the City Council of the City of St. Charles has received the recommendation of the Plan Commission and has considered the same;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of St. Charles, Kane and DuPage Counties, Illinois, as follows:

1. That Section 17.36.020, "Special Uses" of Title 17, "Zoning", of the St. Charles Municipal Code, be and is hereby amended by adding paragraph "N", as follows:

"N. Dog Obedience Schools"


2. That this Ordinance shall become effective from and after its passage and approval in accordance with law.
