

ORDINANCE NO. 1995-M- 53

AN ORDINANCE AMENDING CHAPTER 5.08, "ALCOHOLIC BEVERAGES", OF THE ST. CHARLES MUNICIPAL CODE

WHEREAS, pursuant to its home rule powers and in furtherance of its government and affairs;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Chapter 5.08, "Alcoholic Beverages", Section 5.08.080, "License - Classes and fees", Subparagraph "O" of the St. Charles Municipal Code, is amended by deleting the words, "or R" before the word "license" in the second sentence in line 6 and substituting the word "or" in place of the comma between "C" and "I" immediately prior thereto.

2. That Chapter 5.08, "Alcoholic Beverages", Section 5.08.080, "License - Classes and fees", Subparagraph "P" of the St. Charles Municipal Code, is amended by deleting same.

3. That Chapter 5.08, "Alcoholic Beverages", Section 5.08.080, "License - Classes and fees", Subparagraph "R" of the St. Charles Municipal Code, is amended by deleting same.

4. **"5.08.090 License - Number to be issued.**

There shall be issued not more than a maximum of nine class A, twenty class B, eleven class C, one class D, one class E, three class F, and permitted supplementary license for class D license in any license year, seven class I, plus one license for each of the special restricted classes as set forth in this chapter, plus twenty class N licenses,

provided, no more than two such class N licenses shall be issued for any twenty-four hour period, plus no more than two class O for any twenty-four hour period, plus three class S licenses, plus one class T license."

5. That Chapter 5.08, "Alcoholic Beverages", Section 5.08.340, "Closing hours", Subparagraph "G" of the St. Charles Municipal Code, is amended by deleting same.

6. That Chapter 5.08, "Alcoholic Beverages", Section 5.08.350, "Open hours for package sales", be and is hereby deleted and the following substituted therefor:

"5.08.350 Open hours for package sales.

Class A, Class S and Class T license holders shall limit the sale of packaged liquors from the hours of seven a.m. to ten p.m. except Sunday, on which day hours of sale shall be limited from twelve noon to ten p.m."

7. That Chapter 5.08, "Alcoholic Beverages", Section 5.08.140, "License - Revocation or suspension - Hearing procedure", of the St. Charles Municipal Code, is amended by adding to Subparagraph A, the following:

"In addition to the suspension, the local liquor control commissioner may levy a fine on the licensee for such violations. The fine imposed shall not exceed \$1,000 for each violation; each day on which a violation continues shall constitute a separate violation. Not more than \$10,000 in fines under this Section may be imposed against any licensee during the period of his license. Proceeds from such fines shall be paid into the general corporate fund of the city treasury."

8. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be

published in a newspaper published in and with a general circulation within the City of St. Charles.




