

**AN ORDINANCE AMENDING TITLE 17, "ZONING",
OF THE ST. CHARLES MUNICIPAL CODE
REGARDING WEDDING CHAPELS IN B-2-T DISTRICT**

WHEREAS, a Petition has been filed by the Director of Planning and Development to amend Title 17, "Zoning" of the St. Charles Municipal Code with respect to the provisions of Chapter 17.26, "B2-T Transitional Business District", Section 17.26.020 "Permitted Uses", Subsection "A", "Business service establishments which perform services on the premises:" by adding "19. Wedding Chapel" and

WHEREAS, the Plan Commission of the City of St. Charles has held a public hearing on said Petition in accordance with law; and

WHEREAS, the City Council of the City of St. Charles has received the recommendation of the Plan Commission and has considered the same;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of St. Charles, Kane and DuPage Counties, Illinois, as follows:

1. That Section 17.26.020, "Permitted Uses", subsection (A), "Business service establishments which perform services on the premises:" of Title 17, "Zoning", of the St. Charles Municipal Code, be and is hereby amended by adding item 19, as follows:

"19. Wedding Chapel"

2. That this Ordinance shall become effective from and after its passage and approval in accordance with law.






I further certify that on June 5, 1995, the Corporate Authorities of such municipality passed and approved Ordinance No. 1995-Z-5, entitled
