An Ordinance Amending Title 13, "Public Utilities"
Chapter 13.08, "Electricity," Section 13.08.290,
"Rate 8 - Municipal Owned Street Lighting,"
of the St. Charles Municipal Code

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE
AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 13, "Public Utilities," Chapter 13.08, "Electricity," Section 13.08.290 of the
St. Charles Municipal Code, be and is hereby amended by deleting the same and substituting the
following therefore:

13.08.290 Rate 8 - Municipal Owned Street Lighting and Traffic Signals

- A. Availability. This rate s available only to city of St. Charles owned and maintained street lights and traffic signals.
- B. Charges for this rate shall be as follows:
 - 1. Energy Charge.
\$.049 per kilowatthour for all kilowatthours

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or
published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30)
days after the adoption and approval hereof, be published in a newspaper published in and with a
general circulation within the city of St. Charles.




