



ORDINANCE NO. 1997-M-60

AN ORDINANCE AMENDING CHAPTER 10.41,
"HANDICAPPED PARKING",
OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 10, "Vehicles and Traffic", Chapter 10.41, "Handicapped Parking", Section 10.41.050, "Posting signs", of the St. Charles Municipal Code, be and is hereby amended by adding the following subparagraph E:

"E. On-street public parking, Cedar Street, with two spaces directly in front of St. Patrick's Church with one located 98 feet westerly of North Fourth Street and a second located 129 feet westerly of North Fourth Street. Spacing shall be placed such that the two spaces shall be located on opposite sides of a handicapped curb cut located on the northerly side of Cedar Street."

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


I further certify that on May 19, 1997, the Corporate Authorities of such municipality passed and approved Ordinance No. 1997-M-60, entitled
