**AN ORDINANCE AMENDING CHAPTER 10.40,
"STOPPING, STANDING AND PARKING",
OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND
DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10, "Vehicles and Traffic", Chapter 10.40, "Stopping, Standing and Parking", Section 10.40.020, "City parking - Manner of parking - Improper parking - Curbs - Alleys - Loading", Paragraph F, "Parking in Loading Zones", of the St. Charles Municipal Code, be and is hereby amended by adding the following subparagraph 4:

"4. Along the curb on the east side of North Third Street starting at a point 85 feet north of Main Street and extending northerly thereof for 85 feet."

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.
