





AN ORDINANCE AMENDING TITLE 13, "PUBLIC UTILITIES," CHAPTER 13.16
"WATER," SECTION 13.16.115 OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DUPAGE COUNTIES, ILLINOIS, as follows:

1. THAT TITLE 13, "Public Utilities," Chapter 13.16
"Water," of the St. Charles Municipal Code be and is hereby amended
by inserting the following:

13.16.115 Service pipes - Abandonment

In the event that a service pipe no longer is required to be
connected to the city water supply, the service pipe shall be
properly removed from connection to the city water supply.
Proper removal of a service connection includes, turning off
the corporation stop and severing the service pipe at the
outlet side of the corporation stop. If a service pipe is not
equipped with a corporation stop, disconnection of water
service shall be at the discretion of the Director of Public
Works or his/her designee.

2. That after the adoption and approval hereof, this
Ordinance shall (a) be printed or published in book or pamphlet
form, published by the authority of the City Council, or (b) within
thirty (30) days after the adoption and approval hereof, be
published in a newspaper published in and with a general
circulation within the City of St. Charles.




I further certify that on September 15, 1997, the Corporate Authorities of such municipality passed and approved Ordinance No. 1997-M-99, entitled
