**ORDINANCE NO. 1998-M- 77**

**AN ORDINANCE AMENDING TITLE 8, "HEALTH AND SAFETY"  
CHAPTER 8.24 "GARBAGE AND REFUSE", OF THE  
ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST.  
CHARLES, KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. THAT TITLE 8, "Health and Safety", Chapter 8.24 "Garbage and Refuse" of the St. Charles Municipal Code be and is hereby amended by deleting section 8.24.040B and substituting the following therefore:

**8.24.040 Charges and Bills**

"B. The charges for garbage and rubbish, yardwaste and recyclable material collection service within the corporate limits of the City shall be as follows:

**Single-Family**

Date	Refuse Sticker	Refuse Bag	Yardwaste Bag	Toter (per month) 60 Gal.	90 Gal.
July 1, 1998 - June 30, 1999	\$1.39	\$1.48	\$1.76	\$12.47	\$18.68

**Multi-Family**

Date	Once a Week Service Per Month
July 1, 1998 - June 30, 1999	\$4.49

Multi-family complexes with twice a week service will receive an additional bill from the contracted hauler based on the number of occupied units for the following amounts.


I further certify that on September 8, 1998, the Corporate Authorities of such municipality passed and approved Ordinance No. 1998-M-77, entitled
