



**AN ORDINANCE AMENDING TITLE 10, "VEHICLES AND TRAFFIC,"
CHAPTER 10.11, "RULES OF THE ROAD,"
SECTION 10.11.1600, "THROUGH STREETS,"
OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10, "Vehicles and Traffic," Chapter 10.11, "Rules of the Road," Section 10.11.1600, "Through Streets," of the St. Charles Municipal Code, be and is hereby amended by adding subparagraph 19 to read as follows:

19. 10.11.1600. Fairfax Road from Dunham Road to Huntington Road.

2. That after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council; or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.
