



**AN ORDINANCE AMENDING TITLE 10, "VEHICLES AND TRAFFIC,"
CHAPTER 10.11, "RULES OF THE ROAD,"
SECTION 10.11.1900 and SECTION 10.11.2100
OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10, "Vehicles and Traffic," Chapter 10.11 "Rules of the Road", Section 10.11.1900 "Designated One Way Streets or Alleys" of the St. Charles Municipal Code, shall be amended by adding the following:

Section 10.11.1900.

(D) State Avenue shall be one-way westbound between North 1st Avenue and North 2nd Avenue.

2. That Title 10 "Vehicles and Traffic," Chapter 10.11 "Rules of the Road," Section 10.11.2100 (A) shall be amended by adding the following:

(A) 144 shall be deleted and replaced to the following:

On State Avenue intersecting North 1st Avenue so that Northbound, Southbound, Eastbound and Westbound traffic must stop.

(A) 243 shall be deleted and replaced with the following:

On Peck Road at its intersection with Campton Hills Road so that northbound, southbound, eastbound and westbound traffic must stop.

2. That after the adoption and approval hereof, this Ordinance shall be (i) printed or published in book or pamphlet form, published by the authority of the Council; or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.




I further certify that on December 20, 1999, the Corporate Authorities of such municipality passed and approved Ordinance No. 1999-M-96, entitled
