**ORDINANCE NO. 2000-M- 87**

**AN ORDINANCE AMENDING TITLE 10  
“VEHICLES AND TRAFFIC” CHAPTER 10.11  
“RULES OF THE ROAD” SECTION 10.11.2100  
“INTERSECTIONS WHERE STOP OR YIELD REQUIRED”  
OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,  
KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10 “Vehicles and Traffic” Chapter 10.11 “Rules of the Road,” Section 10.11.2100 “Intersections Where Stop or Yield Required,” shall be amended as follows:

A. By adding Section 10.11.2100(A)(251) which shall read: “On Majestic Oaks Drive at its intersection with Kirk Road so that westbound traffic on Majestic Oaks Drive must stop.”

B. By adding Section 10.11.2100(A)(252) which shall state “On Fox Chase Lane at its intersection with Fox Chase Drive so that southbound traffic on Fox Chase Lane must stop.”

2. That after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.

3. This Ordinance shall be in full force and effect from and after its passage by a vote of the majority of the corporate authorities now holding office and approval in the manner provided by law.


