ORDINANCE NO. 2000-M- 88

AN ORDINANCE AMENDING TITLE 10,
"VEHICLES AND TRAFFIC," CHAPTER 10.11
"RULES OF THE ROAD" SECTION 10.11.1600
"THROUGH STREETS" OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 10, "Vehicles and Traffic," Chapter 10.11, "Rules of the Road," Section 10.11.1600, "Through Streets," of the St. Charles Municipal Code, shall be amended as follows:

A. By adding Section 10.11.1600 (23) which shall read "Fox Chase Drive from Kirk Road to Foxfield Drive, with the exception of the intersections with Kirk Road and Foxfield Drive."

2. That after the adoption and approval hereof, this Ordinance shall be (i) printed or published in book or pamphlet form, published by the authority of the Council; or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


