ORDINANCE NO. 2001-M- 29

AN ORDINANCE AMENDING CHAPTER 6.12,  
"REGULATIONS,"  
OF THE ST. CHARLES MUNICIPAL CODE

---

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,  
KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Chapter 6.12, "Regulations," Section 6.12.110, "Cruelty," of the St. Charles  
Municipal Code, be and is hereby amended by adding Paragraphs H and I.

- "H. Use an electric prod or similar device on any animal at a rodeo  
once the animal is in the holding chute, unless necessary to protect  
the participants and spectators of the rodeo.
- I. Conduct a rodeo without a licensed veterinarian being on call  
during the entirety of the rodeo."

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or  
published in book or pamphlet form, published by the authority of the Council, or (ii) within  
thirty days after the adoption and approval hereof, be published in a newspaper published in and  
with a general circulation within the City of St. Charles.




