

ORDINANCE NO. 2002-M- 21

**AN ORDINANCE AMENDING CHAPTER 3.38 "YARD WASTE USER FEE"
OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Chapter 3.38 "Yard Waste User Fee," 3.38.010 "User Fee" Subsection, of the St. Charles Municipal Code be and is hereby amended by deleting the same and substituting the following therefor:

A user fee is hereby imposed upon single family residences or any building that contains six or fewer dwelling units, whether they be occupied or not, in the amount of **\$2.50** each month.

2. That after the adoption and approval hereof this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.




I further certify that on May 6, 2002, the Corporate Authorities of such municipality passed and approved Ordinance No. 2002-M-21, entitled
