





**AN ORDINANCE AMENDING TITLE 10
"VEHICLES AND TRAFFIC" CHAPTER 10.11
"RULES OF THE ROAD" SECTIONS 10.11.2100
"INTERSECTIONS WHERE STOP OR YIELD REQUIRED"
OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10, "Vehicles and Traffic" Chapter 10.11 "Rules of the Road", Section 10.11.2100 "Intersections Where Stop or Yield Required", of the St. Charles Municipal Code, be and is hereby amended by adding on Foundry Street at its intersection with Seventeenth Street so that westbound traffic on Foundry Street must stop.

2. That after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.

3. This Ordinance shall be in full force and effect from and after its passage by a vote of the majority of the corporate authorities now holding office and approval in the manner provided by law.


I further certify that on May 6, 2002, the Corporate Authorities of such municipality passed and approved Ordinance No. 2002-M-36, entitled
