

ORDINANCE NO. 2002-M-87

AN ORDINANCE AMENDING TITLE 13, "PUBLIC UTILITIES", CHAPTER 13.16,
"WATER",

OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DUPAGE COUNTIES AS FOLLOWS:

1. THAT TITLE 13, "PUBLIC UTILITIES", CHAPTER 13.16 "WATER" of the St. Charles Municipal Code be and is hereby amended by inserting the following:

"13.16.145 Access to premises - discontinuation of water service

- A. Authorized agents of the City of St. Charles shall at all reasonable hours have access to customer premises for the purpose of reading, repairing, examining, replacing or removing water meters connected to the City's water distribution system.
 - B. The City shall have the right to discontinue water service to the customer upon due notice given to the customer whenever access is denied or in the case the customer fails to comply, or perform any of the terms and conditions of this Chapter."
2. That after the adoption and approval hereof, this Ordinance shall (a) be printed and published in book or pamphlet form, published by the authority of the City Council, or (b) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.
