

ORDINANCE NO. 2003-M- 47

AN ORDINANCE AMENDING TITLE 5, "BUSINESS LICENSES AND REGULATIONS," CHAPTER 5.08, "ALCOHOLIC BEVERAGES," SECTION 5.08.090, "LICENSE - NUMBER TO BE ISSUED," OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 5, "Business Licenses and Regulations," Chapter 5.08, "Alcoholic Beverages," Section 5.08.090, "License -Number to be Issued," of the St. Charles Municipal Code, be and is hereby amended by deleting the same and substituting the following therefor:

5.08.090 License - Number to be issued.

There shall be issued not more than a maximum of thirteen class A, *forty-one* class B, nine class C, one class C1, one class D, two class E, four class F, and permitted supplementary license for class D licenses in any license year, one class G, one class H, four class I, plus twenty class N licenses, provided, not more than two such class N licenses shall be issued for any twenty-four hour period, plus no more than two class O for any twenty-four hour period, plus one class R license, one class R1, plus three class S licenses, plus one class T license, plus one class U license.


2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the city of St. Charles.
