



**An Ordinance Amending the St. Charles Municipal Code 13.08 "Electricity"
of the St. Charles Municipal Code**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE
AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Charter 13.08, "Electricity" of the St. Charles Municipal Code, be and is hereby amended by adding the following Section 13.08.062, " Existing Transformer Upgrade" therefore:
 - A. The customer shall pay the exact cost of upgrades to equipment serving the customer facility. A "Transformer Cost Credit" (TCC) may be given for the future replacement of existing transformers based on the accumulated depreciation of the existing asset. Applicability of the TCC and the amount will be determined by SCMEU.

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


I further certify that on December 6, 2004, the Corporate Authorities of such municipality passed and approved Ordinance No. 2004-M-99, entitled
