**An Ordinance Amending Title 3 "Revenue and Finance,"  
Chapter 3.38 "Yard Waste User Fee," by adding 3.38.060, "Definitions,"  
of the St. Charles Municipal Code**

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 3, "Revenue and Finance," Chapter 3.38 "Yard Waste User Fee," of the St. Charles Municipal Code, be and is hereby amended by the addition 3.38.060, entitled "Definitions."

**3.38.060 Definitions.**

**A. Utility Services – Electric, water, sewer, yard waste, and refuse services that are provided by the City or its designated provider.**

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


