City of St. Charles, Illinois Ordinance No. 2010-M-55

An Ordinance Amending Title 10 "Vehicles and Traffic," Chapter 10.40 "Stopping, Standing and Parking," of the St. Charles Municipal Code; No Parking Places Designated – Prohibited Parking

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

SECTION ONE: That Title 10, "Vehicles and Traffic", Chapter 10.40, "Stopping, Standing and Parking", Section 10.40.040, "No Parking Places Designated – Prohibited Parking", of the St. Charles Municipal Code, be and the same is hereby amended by adding thereto a new subsection 10.40.040W., as follows:

Notwithstanding the foregoing, such prohibitions on parking shall not apply to vehicles owned by the City, City employees and/or other vehicles authorized by the City's Electric, Environmental or Public Services managers. The signs designating no parking shall state, "No Parking except for authorized vehicles only".

SECTION TWO: The prohibitions set forth in Section One of this Ordinance shall be in full force and effect following the posting of signs as provided in Section 10.40.080 of the St. Charles Municipal Code.


SECTION THREE: That after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form pursuant to the authority of the City Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.

SECTION FOUR: This Ordinance shall be in full force and effect ten (10) days from and after its passage by a vote of the majority of the corporate authorities now holding office, approval and publication in the manner provided by law.
