



**Ordinance No. 2013-M- 10**

**An Ordinance Amending Title 10 "Vehicles and Traffic", Chapter 10.11 "Rules of the Road," of the St. Charles Municipal Code**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

SECTION ONE: That Title 10 "Vehicles and Traffic", Chapter 10.11 "Rules of the Road", of the St. Charles Municipal Code, is hereby amended by adding thereto a new Section 10.11.2385 as follows:

**"10.11.2385 Pedestrians Prohibited on Red Gate Bridge.**

Pedestrians are prohibited from the Red Gate Bridge from a point at the eastern most right of way of North 2<sup>nd</sup> Street at the intersection with Red Gate Road, to a point at the western most right of way of North 5<sup>th</sup> Avenue at the intersection with Red Gate Road. Pedestrian traffic on the Red Gate Bridge and all approaches shall be restricted to the trail bridge only and is prohibited on the highway bridge."

SECTION TWO: That, after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the City Council of the City of St. Charles, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


SECTION THREE: This Ordinance shall be in full force and effect ten (10) days from and after its passage by a vote of the majority of the corporate authorities now holding office, approval and publication in the manner provided by law.


