



BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST.
CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Chapter 2.04, "City Council", Section
2.04.020, "Meetings - Time and Place", of the St. Charles
Municipal Code, be and is hereby amended by deleting the
same and substituting the following therefor:

"2.04.020 Meetings - Time and place.
The regular meetings of the city council
shall be held at the St. Charles municipal
center on the first and third Mondays of every
month at the hour of seven o'clock p.m.;
provided, that if the regular meeting falls
on the first day of January, commonly called
New Years Day, the 30th day of May, the 4th
day of July, the 25th day of December,
commonly called Christmas Day, the first
Monday in September, to be known as Labor
Day, the meeting shall take place on the next
secular day at the same hour. Adjourned
meetings may be held at such time as the
city council may determine."

2. That after the adoption and approval hereof the
Ordinance shall (i) be printed or published in book or
pamphlet form, published by the authority of the council, or
(ii) within thirty (30) days after the adoption and approval
hereof, be published in a newspaper published in and with a
general circulation within the City of St. Charles.
