

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST.
CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Chapter 2.04, "City Council", Section 2.04.040, "Aldermen - Salary", of the St. Charles Municipal Code, be and is hereby deleted and the following substituted therefor:

"2.04.040 Aldermen - Salary.


Each alderman that is elected and takes office on or after April 2, 1991 shall be paid a salary of One Hundred Twenty-Five Dollars for each regular, special or adjourned council meeting as required by law, The current aldermen of the council, and any others who shall complete the unexpired terms of current aldermen, shall serve out their remaining terms, after such date, at their current salary of One Hundred Dollars or Seventy Five Dollars, as the case may be, for each regular, special or adjourned council meeting. Until April 2, 1991 each alderman shall continue to receive the current salary of One Hundred Dollars or Seventy Five Dollars, as the case may be, for each regular, special or adjourned council meeting."

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.
