

ORDINANCE NO. 1973-M-3

ORDINANCE AMENDING CHAPTER 9, ARTICLE VIII

OF

THE MUNICIPAL CODE OF THE CITY OF ST. CHARLES

WHEREAS, Chapter 9, Article VIII, Section 9.801 of the Municipal Code creates a Plan Commission for the City of St. Charles consisting of the Mayor who shall act as an ex-officio member and thirteen additional members who shall be appointed by the Mayor with the advice and consent of the City Council, and;

WHEREAS, Chapter 9, Article VIII, Section 9.802 provides that a majority of the Plan Commission shall constitute a quorum, but no final action shall be taken on any measures before it except with the concurrence of the majority of the members; and

WHEREAS, it is in the best interest of the City of St. Charles that said Municipal Code be amended by (a) increasing the number of members from thirteen to fifteen; (b) providing that nine members of the Plan Commission shall constitute a quorum; and (c) providing that final action shall be taken upon measures before it with a concurrence of the majority of the members present.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of St. Charles, that the Municipal Code of the City of St. Charles, as approved by the City Council March 16, 1965, and as amended from time to time thereafter is hereby amended as follows:

That Chapter 9, Article VIII, entitled Plan Commission Section 9.801 entitled Creation shall read:

"The Plan Commission of the City of St. Charles shall consist of the Mayor who shall be an ex-officio member and fifteen additional members who shall be appointed by the Mayor with the advice and consent of the City Council."

That Chapter 9, Article VIII entitled Plan Commission Section 9.802 entitled Quorum shall read:

"Nine members of the Plan Commission shall constitute a quorum. Final action shall be taken upon measures before the Plan Commission with a concurrence of a majority of the members present."


That it is the express intent of this Amendment to increase the number of members sitting on the Plan Commission from thirteen to fifteen; to increase the quorum requirement of the Plan Commission from a majority to nine members, and to provide that final action upon measures before the Plan Commission shall be taken with a concurrence of a majority of the members present. Any other interpretation given hereto shall be deemed incorrect.

This Amendatory Ordinance shall be in full force and effect from and after its passage.
