## ORDINANCE NO. 1979-M- 24

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DUPAGE COUNTIES, ILLINOIS, as follows:

1. That Chapter XV, Article III - Meters and Rates, Sections 15.302, 15.303, 15.305A and C, and 15.306 be amended to read hereafter as follows:



- 15.302 Installation. Water meters shall be installed by members of the Meter Department. The location of the meter shall be of easy access and will be approved by the Building Inspector or Meter Department Foreman, prior to installation. All necessary piping and fittings necessary to facilitate the meter installation, including a 125 pound brass gate valve at each end of the meter shall be furnished by the consumer prior to the installation. The meter shall be sealed upon completion of the installation.
- 15.303 Reading Meters. The Comptroller shall cause to be read monthly every water meter used on the City distribution system so that water bills may be sent out at the proper time.
- 15.305 Rates. All property upon which any building has been or may be hereafter erected having a connection with the water system shall pay the following net charges:
- A. \$1.50 per month plus the following charge for water used per month:
  \$.82 per thousand gallons
- C. The gross charge shall be 10 percent more than the net charge.

15:306 Bills for Water Used. Bills for water service will be rendered monthly. Net charges are due and payable on or before fifteen days following date of issuance and the gross charge becomes payable thereafter.

The City will accept the net amount of the bill as full payment for one monthly net period in each fiscal year, after expiration of the net payment period.

This ordinance shall be in full force and effect from and after its passage, approval and publication pursuant to law.
