WHEREAS, Chapter 24 (Illinois Municipal Code) Section 9-2-7 provides in pertinent part:

". . .In cities having a population of less than 50,000. . ., the Board of Local Improvements shall consist of the Mayor of the City, . . .and the Public Engineer and the Superintendent of Streets of the municipality, where such officers are provided by Ordinance. But if at any time such officers are not so provided for, the corporate authorities, by Ordinance, shall designate two or more members of their body who, with the Mayor. . .shall constitute the members of the board, until otherwise provided by Ordinance. The Mayor. . .shall be the President of the Board."

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, ILLINOIS:

1. Chapter 9 entitled Boards and Commissions is hereby amended by amending Article XI which shall read as follows:

"Article XI Board of Local Improvements
10.001 Creation) There is hereby created a Board of Local Improvements of the City of St. Charles. The Mayor shall be President of the Board. Alderman James Smick, Alderman Vivian Manda, Alderman Ernest Byrd, and Alderman Alphonse Dewitte, and the Superintendent of Streets and Sewers, and the City Engineer, shall be members of the Board. The said persons shall constitute the membership of the Board.


10.1002 Duties) It shall be the duty of the Board of Local Improvements to carry out the responsibilities imposed upon them in accordance with law."

2. This ordinance shall be effective upon its presentation, passage and approval pursuant to law.



