AN ORDINANCE AMENDING CHAPTERS 20, 21, 22,  
23, 25 and 27 OF THE MUNICIPAL CODE OF THE  
CITY OF ST. CHARLES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF  
ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, as follows:

1. That Chapter 20 of the Municipal Code of the  
City of St. Charles be and is hereby amended as follows:

- a. Article IX entitled "License Requirement  
and Fee - Dog" be and is hereby repealed.
- b. Article XX entitled "Cats", Section 20.50  
entitled "Licensing" be and is hereby  
repealed.

2. That Chapter 21 of the Municipal Code of the  
City of St. Charles entitled "Licenses and Permits"  
Section 21.007, entitled "Fees" be and is hereby deleted and  
the following substituted therefor:

"21.007 Fees.) In the absence of provision to  
the contrary, all fees and charges for licenses  
or permits shall be paid in advance at the time  
application therefor is made to the City Clerk.  
When an applicant has not engaged in the business  
until after the expiration of part of the current  
license year the license fee shall not be pro-  
rated for any fraction of the license year, but  
the applicant shall be required to pay the full  
license fee. There shall be no refund for cancella-  
tion or termination of a license for any reason,  
unless otherwise provided. Except as otherwise  
provided, all license fees shall become a part of  
the general fund. A new applicant shall pay two (2)  
times the annual license fee upon making application  
as and for the first year license fee."

3. That Chapter 22 of the Municipal Code of the City  
of St. Charles entitled "Amusements" be and is hereby amended as  
follows:

a. In Article I entitled "General Provisions" Section 22.101 entitled "Application" and Section 22.102 entitled "Licenses" be and are hereby deleted and the following substituted therefor:

"22.101 Application.) The provisions of this article shall apply to all public shows, theatricals, circuses and other amusements in this City, whether specifically licensed in another article in this chapter or not."

"22.102 Licenses.) It shall be unlawful to conduct or operate any amusement which is open to the public and for admittance to which a fee is charged, without having first obtained a license therefor; provided that the provisions of this section shall not be held to apply to those amusements which are specifically licensed by any other ordinance of the city.

Applications for such license shall be made to the Clerk and shall comply with all of the general provisions of the ordinances relating to such application. "

b. In Article II entitled "Billiards" Section 22.202 entitled "Fees" be and is hereby deleted and the following substituted therefor:

"22.202 Fees) The annual fees for any such license shall be \$25.00 for each table."

c. In Article III entitled "Bowling Alleys" Section 22.302 entitled "Fee" be and is hereby deleted and the following substituted therefor:

"22.302 Fee.) The annual fee for such licenses shall be \$60.00 for each alley."

d. In Article IV entitled "Motion Pictures" Section 22.403 entitled "Fees" is deleted and the following substituted therefor:

"22.403 Fees.) Any person securing an annual license for motion pictures or theatricals, naming a specific place or building where the performances are to be presented, may present therein any number of performances, including theatricals, during the year for which the license was secured without having to pay an additional fee. The annual fee for such licenses shall be \$200.00, except if there shall be more than one theater screen in said building, in which case the annual fee for such license shall be \$200.00 per theater screen."

4. That Chapter 23 of the Municipal Code of the City of St. Charles entitled "Food Dealers" be and is hereby amended as follows:

a. Section 23.103 entitled "Fees" be and is hereby deleted and the following substituted therefor:

"23.103 Fees.) The annual license fee shall be \$50.00 for each business licensed hereunder unless a separate and different fee is provided for in the article relating thereto.

b. That in Article IV entitled "Restaurants" Section 23.402 entitled "Fees" be and is hereby deleted and the following substituted therefor:

"23.402 Fees.) The fees for operation shall be paid in accordance with the following schedule:

Restaurants -\$50.00 payable annually.

Itinerant Restaurants - \$2.00 for a daily fee; provided, however, that no more than \$50.00 shall be charged for such itinerant restaurant operation for continuous operation for any period of time not exceeding one year."

c. That in Article V entitled "Food Refrigeration Locker Plants" Section 23.503 entitled "Fee" be and is hereby deleted and the following substituted therefor:

"23.503 Fee.) The annual fee for such license shall be \$50.00.

5. That Chapter 25 entitled "Other Businesses Licensed" be and is hereby amended as follows:

a. That in Article I entitled "Auctioneers" Section 25.106 entitled "Fees" be and is hereby deleted and the following substituted therefor:

"25.106 Fees.) The fees for auctioneers' license shall be: For a license for one day \$5.00. For an annual license \$25.00."

b. That in Article III entitled "Barbershops" Sections 25.301 entitled "License Required", 25.302 entitled "Application", 25.303 entitled "Fee" be and are hereby repealed and Section 25.307 entitled "Penalty" be and is hereby deleted and the following substituted therefor:

"25.307 Penalty.) Any person, firm or corporation violating any provision of this article shall be fined not less than \$5.00 nor more than \$500.00 for each offense; and a separate offense shall be deemed committed on each day during or on which a violation occurs or continues."

c. That in Article IV entitled "Cigarette Dealers" Section 25.402 entitled "Fee" be and is hereby deleted and the following substituted therefor:

"25.402 Fee.) The annual fee for such license shall be \$50.00 and where vending machines are used for such sale an additional fee of \$50.00 shall be paid for each machine."

d. That in Article VIII entitled "Peddlers" Section 25.803 entitled "Fee" be and is hereby repealed.

e. That in Article IX entitled "Refuse Collectors" Section 25.903 entitled "Fee" be and is hereby deleted and the following substituted therefor:

"25.903 Fee.) The annual fee for such license shall be \$500.00."

f. That in Article VI entitled "Handbills" Section 25.610 entitled "Distributors - License, Fee" sub-section (d) be and is hereby repealed; and further in said Article VI, Section 25.615 be and is hereby deleted and the following substituted therefor:

"That all ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed."

6. That in Chapter 27 entitled "Miscellaneous Regulations" in Article VII entitled "Sound Amplifiers" Section 27.702 entitled "Fees" be and is hereby repealed.


7. That this Ordinance shall be in full force and effect from and after its passage, approval and publication in accordance with law.


