AN ORDINANCE AMENDING CHAPTER 13.16, "WATER", SECTION 13.16.220, "SHUTOFF FOR NONPAYMENT OF BILLS", AND SECTION 13.16.230, "LIEN - NOTICE OF DELINQUENCY", SUBSECTION A, OF THE ST. CHARLES MUNICIPAL CODE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, as follows:

1. That Section 13.16.220, "Shutoff for Nonpayment of Bills", of the St. Charles Municipal Code, be and is hereby deleted and the following substituted therefor:

" The water supply may be shut off from any premises for which the bill remains unpaid for thirty days after it has been rendered. When shut off, the service shall not be renewed except upon payment of twenty dollars for turning on the water."

2. That Section 13.16.230, "Lien - Notice of Delinquency", Subsection A, of the St. Charles Municipal Code, be and is hereby deleted and the following substituted therefor:

"A. Whenever a bill for water service remains unpaid sixty days after it has been rendered, the city clerk shall file with the county recorder of deeds of Kane County a statement of lien claim. This statement shall contain the legal description of the premises served, the amount of the unpaid bill and a notice that the city claims a lien for this amount as well as for all charges for water subsequent to the period covered by the bill."

3. This Ordinance shall be in full force and effect from and after its passage, approval and publication pursuant to law.


