AN ORDINANCE AMENDING TITLE 5, CHAPTER 5.08, ALCOHOLIC BEVERAGES, SECTION 5.08.080 ENTITLED "LICENSE - CLASSES AND FEES" (A) AND 5.08.090 ENTITLED "LICENSE - NUMBER TO BE ISSUED" OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, as follows:

1. That Title 5, Chapter 5.08, entitled "Alcoholic Beverages, Section 5.08.080, entitled "License - Classes and Fees, "Sub-Section "A", of the St. Charles Municipal Code be and is hereby deleted and the following substituted therefor:


"A. Class A licenses shall authorize the retail sale of alcoholic liquors in packages and not for consumption on the premises. Curb service or sale is prohibited. However, if the Class A licensee is located in the same building as a food store or drug store, or in an adjoining building, the entrance to the liquor licensee's facility shall be by means of a separate entrance from the out of doors and if there is access from the food store or drug store, it shall be by a controlled access, by means of a turnstile, which provides a restricted entrance only through a solid permanent dividing wall where the dividing wall runs from floor to a minimum of 72 inches in height with a control device that spans the remainder of the space between the top of the wall and the ceiling. The turnstile entrance shall include means of locking off the entrance after hours. The annual license fee for such license shall be \$1,200.00."

2. This Ordinance shall be in full force and effect from and after its passage, approval and publication in accordance with law.


