AN ORDINANCE AMENDING TITLE 3, "REVENUE AND FINANCE" BY ADDING CHAPTER 3.28, "AUTOMOBILE RENTING USE TAX ACT" TO THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY

OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, THAT:

1. That Title 3 "Revenue and Finance" of the St. Charles Municipal Code be and is hereby amended by adding thereto Chapter 3.28 "Automobile Renting Use Tax Act" as follows:

"3.28 Automobile Renting Use Tax Act;

3.28.010 A tax is hereby imposed upon the privilege of using in this City an automobile which is rented from a renter outside Illinois and which is titled or registered with an agency of this state's government in this City at the rate of one percent of the rental price of such automobile while this Ordinance is in effect, in accordance with the provisions of Section 8-11-8 of the Illinois Municipal Code.

3.28.020 Every such person engaged in such business in the City shall file on or before the last day of each calendar month, the report to the State Department of Revenue required by Sections Two and Three of "An Act in Relation to a Tax upon Persons Engaged in the Business of Selling Tangible Personal Property to Purchasers for Use or Consumption" approved June 29, 1933, as amended.

3.28.030 At the time such report is filed, there shall be paid to the State Department of Revenue the amount of tax hereby imposed on account of the renting of automobiles during the preceding month."


2. The City Clerk is hereby directed to transmit to the State Department of Revenue a certified copy of this Ordinance not later than five (5) days after the effective date of this Ordinance.

3. This Ordinance shall be published within ten (10) days of its enactment as provided in Paragraph 1-2-4 of the Illinois Municipal Code and shall be effective the first day of the month next following the expiration of the publication period. Certified proof of publication shall be forwarded to the State Department of Revenue along with a certified copy of this Ordinance as required by Section 2.


