BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST.
CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Chapter 5.08 entitled, "Alcoholic Beverages",
Section 5.08.080, "License-Classes and Fees", be and is
hereby amended by deleting Subsections "B" and "C" and
substituting the following therefor:

- B. Class B licenses shall authorize the retail sale of alcoholic liquors on the premises of any tavern (1) for consumption on the premises; provided, that if located in a hotel or motel, there shall be no retail package sales nor any room service. The annual license fee for such licenses shall be one thousand dollars.
- C. Class C licenses shall authorize the retail sale of alcoholic liquors on the premises of any tavern (2) for consumption on the premises. The annual license fee for such license shall be one thousand dollars.

2. That this Ordinance shall be in full force and effect from and after its passage, approval and publication in accordance with law.


