BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF
 ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS
 FOLLOWS:

1. That Chapter 5.08 "Alcoholic Beverages", Section
 5.08.090 "License-Number to be Issued", be and is hereby
 amended by deleting the same and substituting the follow-
 ing therefor:

"There shall be issued not more than a
 maximum of six (6) Class "A", ten (10)
 Class "B", eleven (11) Class "C", one
 (1) Class "D", one (1) Class "E", three
 (3) Class "F", and permitted supplementary
 license for Class "D" licenses in any
 license year, three (3) Class "I", plus
 one (1) license for each of the special
 restricted classes as set forth herein,
 plus twelve (12) Class "N" licenses."

2. Penalty. Any person, firm, or corporation violat-
 ing any provision of this Ordinance shall be fined not
 less than \$25.00 nor more than \$500.00 for each offense and
 a separate offense shall be deemed committed on each day
 during or on which a violation occurs or continues.

3. That this Ordinance shall be in full force and
 effect from and after its passage, approval and publication
 in accordance with law.


