BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, THAT:

1. That Title 3 "Revenue and Finance" of the St. Charles Municipal Code be and is hereby amended by deleting Chapter 3.28 "Automobile Renting Use Tax" and substituting the following therefore:

"3.28 Automobile Renting Use Tax;

3.28.010 A tax is hereby imposed upon the privilege of using in this City an automobile which is rented from a rentor outside Illinois and which is titled or registered with an agency of this state's government in this City at the rate of one percent of the rental price of such automobile while this Ordinance is in effect, in accordance with the provisions of Section 8-11-8 of the Illinois Municipal Code.

3.28.020 The tax provided for in this Ordinance shall be collected from the persons whose Illinois address for titling or registration purposes is given as being in this City.

3.28.030 The tax imposed by this Ordinance shall be paid to the Illinois Department of Revenue."

2. The City Clerk is hereby directed to transmit to the State Department of Revenue a certified copy of this Ordinance not later than five (5) days after the effective date of this Ordinance.

3. This Ordinance shall be effective on the first day of the second calendar month next following publication as provided in the Municipal Code Section 1-2-4. Certified proof of publication shall be forwarded to the Illinois Department of Revenue along with the certified copy of this Ordinance required by Section 2.




