BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST.  
CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Chapter 9.60, "Weapons", Section 9.60.020,  
"Discharge of Firearms", be and the same is hereby amended  
by deleting said section and substituting the following  
therefor:

"9.60.020 Discharge of firearms.


It is unlawful to discharge any firearms  
or airgun in the city; provided, that this  
section shall not be construed to prohibit  
any officer of the law from discharging a  
firearm in the performance of his duty, nor  
to prohibit any citizen from discharging  
a firearm when lawfully defending his person  
or property, nor when discharged pursuant to  
a written permit authorized by the City  
Council and issued by the Mayor. Such permit  
shall limit the time and place for the firing  
and shall be issued only if for memorial  
services for the dead, burials, or such other  
circumstances where the City Council shall  
find the public health and safety shall not  
be damaged. The City Council shall have the  
right to specify conditions attached to such  
permit."

2. That this Ordinance shall be in full force and  
effect from and after its passage, approval and publication  
in pamphlet form in accordance with law which publication  
in pamphlet form is hereby authorized.


