BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 2, "Administration and Personnel", Chapter 2.6, "Board of Local Improvements", Section 2.16.010, "Created - Membership", of the St. Charles Municipal Code, be and the same is hereby deleted and the following substituted therefor:

"2.16.010 Created - Membership.

There is created a board of local improvements of the city. The mayor shall be president of the board. Alderman Carol Nichols, Alderman Alphonse DeWitte and Alderman Gustave Enzenbacher, and the superintendent of streets and sewers, and the city engineer, shall be members of the board. The said persons shall constitute the membership of the board."

2. That this Ordinance is in full force and effect from and after its passage and approval in accordance with law.


