

AN ORDINANCE AMENDING TITLE 5, CHAPTER 5.08,  
"ALCOHOLIC BEVERAGES", OF THE ST. CHARLES  
MUNICIPAL CODE BY ADDING SECTION 5.08.285,  
"RESPONSIBILITY OF THE OWNER OR OCCUPANT OF  
PREMISES"

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF  
ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS  
FOLLOWS:

1. That Chapter 5.08 "Alcoholic Beverages", of  
the St. Charles Municipal Code be and is hereby amended  
by adding Section 5.08.285, "Responsibility of the  
Owner or Occupant of Premises", as follows:


"It shall be unlawful for any owner or  
occupant of any premises located within  
the City to knowingly allow a minor to  
remain on such premises while in the  
possession of alcoholic liquor or  
while consuming alcoholic liquors in  
violation of the St. Charles Municipal  
Code."

2. That this Ordinance shall be in full force and  
effect from and after its passage, approval and  
publication in accordance with law, and publication in  
pamphlet form is hereby authorized and directed.




