



BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST.  
CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Chapter 2.30, "Fire Department", Section  
2.30.010, "Created - Composition", of the St. Charles  
Municipal Code, be and the same is hereby amended by delet-  
ing said section and substituting the following therefor:

"2.30.010 Created - Composition.


There is created a fire department, an executive department of the city. The full-time fire department shall consist of the fire chief, assistant chief, two captains, five firemen, and such other members as may be provided for from time to time by the mayor and city council. The additional members of the fire department are to be known as paid on-call firemen. The paid on-call firemen shall not exceed fifty in number and not less than thirty. Within this group a yearly election shall be held to elect a president, secretary, treasurer and such other members as may be provided for from time to time, subject to approval of the mayor and city council. All members of the fire department including the fire chief are to be considered employees of the city."

2. That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form in accordance with law which publication in pamphlet form is hereby authorized.




