BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 2, "Administration and Personnel", Chapter 2.32, "Police Department", Section 2.32.010, "Created - Composition" of the St. Charles Municipal Code, be and is hereby deleted and the following substituted therefore:

"2.32.010 Created - Composition.

There is created a Police Department, an executive department of the City. The Police Department shall consist of the Chief of Police, two Lieutenants, five Sergeants, four Corporals, twenty-four Patrol Officers, and such other members that may be provided for from time to time by the Mayor and City Council. All appointed Police Officers of the Police Department, including the Chief of Police, are to be considered employees of the City."

2. That this Ordinance shall be in full force and effect from and after its passage and approval in accordance with law.
