



AN ORDINANCE AMENDING CHAPTER 5.08, "ALCOHOLIC BEVERAGES" OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Chapter 5.08, "Alcoholic Beverages", Section 5.08.080, Subsection K, of the St. Charles Municipal Code, be and is hereby amended by deleting the same and substituting the following therefor:

"K. Class K licenses shall authorize all class B, C, E and F license holders who desire to provide live entertainment on any Saturday night until two a.m. Sunday to hold a supplemental entertainment license. The yearly fee for said supplemental license shall be six hundred dollars."

2. That Chapter 5.08, "Alcoholic Beverages", Section 5.08.080, Subsection N, of the St. Charles Municipal Code be and is hereby amended by deleting the words, "one" and "license" and substituting the words, " six " and "licenses" respectively in the sentence which will hereafter read as follows:

"No more than six such licenses shall be issued to any organization within any three-hundred-sixty-five-day period."

3. That Chapter 5.08, "Alcoholic Beverages", Section 5.08.090, "License - Number to be issued", of the St. Charles Municipal Code, be and is hereby deleted and the following

substituted therefor:

"5.08.090 License - Number to be issued.

There shall be issued not more than a maximum of seven class A, twelve class B, eleven class C, one class D, one class E, three class F, and permitted supplementary license for class D licenses in any license year, three class I, plus classes as set forth in this chapter, plus twenty class N licenses. After December 31, 1984 there shall be no more than twelve class N licenses issued in any license year."

4. That Chapter 5.08, "Alcoholic Beverages", Section 5.08.340, "Closing hours", be and is hereby amended by adding Subsection D thereto as follows:


"D. All class N license holders between the hours of midnight and seven a.m. and between the hours of ten p.m. and midnight."

5. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.
