



BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST.
CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Section 8.08.030 of the St. Charles Municipal
Code be and is hereby amended by deleting the same and
substituting the following:

"8.08.030 Exemptions.


- A. This chapter shall not apply to any valid permit issued pursuant to the Illinois Aeronautics Act prior to the effective date of the ordinance codified in this chapter.
- B. This chapter shall not apply to aircraft used in building construction, medical emergencies, movie making, and special events approved by the City Council or to a hot air balloon, provided the user of such aircraft or hot air balloon shall have first:
 - 1. Notified the city in writing of the intended use including date, location and amount of time necessary;
 - 2. Provided a certificate of insurance showing liability insurance for property damage and personal injury in an amount and form satisfactory to the city council;
 - 3. Provided an indemnification agreement in a form with a surety both acceptable to the city council."

2. That this ordinance shall be in full force and effect from and after its approval and publication in accordance with law and publication in pamphlet form is hereby authorized and directed.


