

**WHEREAS**, a Petition has been filed for amending Title 17, "Zoning", Chapter 17.26, "B-2-T Transitional Business District", Section 17.26.020, "Permitted Uses", Subsection A, of the St. Charles Municipal Code; and

**WHEREAS**, the Plan Commission of the City of St. Charles has held a public hearing on said Petition in accordance with law; and

**WHEREAS**, the City Council of the City of St. Charles has received the recommendation of the Plan Commission and has considered the same;

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of St. Charles, Kane and DuPage Counties, Illinois, as follows:

1. That Title 17, "Zoning", Chapter 17.26, "B-2-T Transitional Business District", Section 17.26.020, "Permitted Uses", Subsection A, of the St. Charles Municipal Code be and is hereby amended by adding thereto the following:

18. Travel agency

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.
