

BE IT ORDAINED, by the City Council of the City of St. Charles, Kane and DuPage Counties, Illinois, that:

1. Chapter 2.30 of the St. Charles Municipal Code be and is hereby amended by deleting Section 2.30.010 thereof and inserting the following in its place.

"2.30.010 Created - Composition.

There is created a fire department, an executive department of the City. The full-time fire department shall consist of the fire chief, assistant chief, two captains, twelve firemen, and such additional members as may be provided for from time to time by the mayor and city council. Such additional members of the fire department are to be known as paid-on-call firemen. The paid-on-call firemen shall not exceed fifty in number and not less than thirty. Within this group a yearly election shall be held to elect a president, secretary, treasurer, and such other members as may be provided for from time to time. All members of the fire department including the fire chief are to be considered employees of the city."

2. That after adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty days after adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles, Kane and DuPage Counties, Illinois.
