



BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 10, "Vehicles and Traffic", Chapter 10.40, "Stopping, Standing and Parking", Section 10.40.040, "No-parking places designated -prohibited parking", Paragraph "L" of the St. Charles Municipal Code, be and is hereby amended by deleting the same and substituting the following therefor:

"L. On a sidewalk, except between the hours of 10 p.m. and 7 a.m. when vehicles may be parked in residentially zoned districts on that portion of the sidewalk which connects the driveway and the driveway apron."

2. The Superintendent of Streets and Sewers shall cause signs to be posted in all areas where parking is prohibited, indicating such prohibitions.

3. Any person who violates any of the provisions of this Ordinance shall, upon conviction, be fined not less than Ten Dollars (\$10.00) nor more than Five Hundred Dollars (\$500.00) for each offense, and each day shall be considered a separate offense.

4. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval

hereof, be published in a newspaper in and with a general circulation within the City of St. Charles.
