AN ORDINANCE AMENDING CHAPTER 2.06, "CITY CLERK",
BY ADDING SECTION 2.06.145, "CITY CLERK - SALARY"

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Chapter 2.06, "City Clerk", of the St. Charles
Municipal Code be and is hereby amended by adding Section 2.06.145,
"City Clerk - Salary", as follows:

"2.06.145 City Clerk - Salary. The city clerk
that is elected and takes office on or after the
general municipal election in April, 1989 shall be
paid a salary of Two Thousand Four Hundred Dollars
per year for attendance at city council meetings
and the performance of other duties prescribed
by statute and ordinance. The current city clerk
and any other city clerk who shall complete the
unexpired term of the current city clerk shall
serve out such remaining term at the current
salary of One Thousand Eight Hundred Dollars per
year."

2. That after the adoption and approval hereof the
Ordinance shall (i) be printed or published in book or pamphlet
form, published by the authority of the Council, or (ii) within
thirty (30) days after the adoption and approval hereof published
in a newspaper in and with a general circulation within the
City of St. Charles.




I, Jean M. Connors, certify that I am the duly elected and acting municipal clerk of the City of St. Charles, Kane and DuPage Counties, Illinois.
